Rapid Relief and Recovery Fund Grants	 Mr. Ulreich and Mr. Elfenbaum presented an overview of the Rapid Relief and Recovery Fund ('RRR Fund') Grants Committee meeting and explained that the proposed grants were being accelerated due to immediate need. Of the \$505,000 available for distribution, split into two separate pools for agencies and synagogues, the following grants were proposed: 1. \$50,000 to the Mandell Jewish Community Center for general operating support from the agency fund

	 2. \$30,000 each to the New England Jewish Academy and Solomon Schechter Day School for scholarship support from the agency fund 3. \$5,000 to Mikveh Bess Israel for operations from the agency fund 4. \$25,000 for four constituents of Chabad of Greater Hartford for operating support from both funds: \$5,000 to Chabad of the Valley (synagogue); \$5,000 to Chabad East of the River (synagogue); \$10,000 to Chabad of West Hartford (synagogue); and \$5,000 to Chabad of UHart (agency) The Trustees asked clarifying questions about the financial situations of the grantees. Mr. Schreiber noted that these and other agencies would likely also request grants from the Foundation's Community Grants Program. HSC Loan Request Summary

July 24, 2020

Hebrew Health Care, Inc., (dba Hebrew Senior Care) has requested a short-term loan of \$183,828 from the Foundation to pay its outstanding obligations to Enterprise Builders (\$225,000), which built the addition to HSC's Behavioral Health Unit, and to Pullman Comely (\$250,000) for legal fees connected to the bankruptcy and others services rendered. The Foundation loan is part of a "package" of funding being provided by Henry Zachs and Bob Goldfarb through respective funds held at the Foundation.

The Foundation's loan will be "secured" by \$187,500 in outstanding pledges made by three of the community's major donors; HSC will make payments to the Foundation immediately upon receipt of each pledge payment (see attached budget and timeline). We anticipate receiving about half the payments by the beginning of October, while all payments are to be remitted to the Foundation by December 31, 2020. The Foundation would fund the loan to HSC from its unrestricted funds.

The urgent need for cash is based on a few factors:

- Pullman Comely threatened to sue HSC for \$400,000 in unpaid legal bills; through negotiations, they agreed to a settlement of \$250,000 if the bill was paid by July 31, 2020.
- Enterprise has shown good faith in laying out the money for construction and needs to be paid.
- While the HSC Behavioral Health Unit is operating at or near capacity, it has to wait 60-90 days to begin receiving Medicare payments.
- A number of patients that would normally have been discharged to nursing homes days or weeks ago, are being kept at HSC because nursing homes are not accepting them during the pandemic. HSC must care for them and can't bill Medicare/insurance for reimbursement until after they are discharged.

Also of note:

In July 2016, the Foundation made a \$200,000 grant to HSC for transitional operating support to help alleviate the agency's severe cash flow issues. One of the stipulations of the grant is as follows: "Subject to its capacity to do so, HHC will repay, on a periodic basis, any draws on the TOS into a permanent endowment fund for HHC to be held at JCF starting no later than two years from the date of its first draw."

The difference between that open-ended "recoverable grant" and the *loan* being requested now are the five-month timetable for repayment and the identifiable sources of funds from which HSC will make these payments. The risk is that further economic fallout from Covid-19 could result in donors delaying their payments.
