#### Jessica L. Fish

Jessica is deeply committed to Jewish communal life. Jessica is a Trustee Emerita of the Jewish Community Foundation (2018–2024) and now returns to the Foundation's Board. She is already actively involved as a member of the Grants Committee and she served as Co-Chair of the 50th Mosaic Project in 2022. Jessica and her husband Michael established the Jessica and Michael Fish Family Fund in honor of the Foundation's 50th Anniversary.

Jessica has become deeply involved in the Jewish Federation's community work, including serving as a cochair of Women's Philanthropy's Pearl Society, co-chairing the CEO search committee that hired David Waren and participating on numerous committees including governance and allocations. Jessica cochaired VOICES both in 2018 and 2025, and chaired the PASC Engagement and Outreach Subcommittee. She also serves on Federation's new Women's Philanthropy Cabinet.

In Greater Hartford, he has been involved in both formal and informal Jewish education of teenagers including as an educator at the Jewish Teen Learning Connection.
